## 1. Background

Describe relevant background to the implementation of the policy. Pursuant to Board Policy 9270 and Ohio Rev. Code 3321.03 and 3321.04, the Board of Education encourages the enrollment of all school age children residing in Cincinnati Pubic Schools boundaries. The Board recognizes its responsibility for assuring that every resident school-age child is enrolled in an approved program or is offered an equivalent education elsewhere and designates the Superintendent to act in its behalf. All requests to educate a child in an equivalent education (home schooling) program are to be submitted to the Superintendent according to Ohio Administrative Code 3301-34. The Superintendent may allow a student who is home educated at home or at a non-District school to participate in one or more of the District's co-curricular or extra-curricular activities providing the student meets the District and Ohio High School Athletic Association eligibility criteria.

Review parent's Home Education Notification for compliance. Excusal letter for parent/child issued and signed by superintendent within 14 days. Enroll student into PowerSchool.

If parent's notification is incomplete, notify parent in writing within 14 days requesting information that is not provided.

If the superintendent finds the parent's notification to instruct a child at home has not been submitted, is incomplete or does not comply with the laws, the attendance officer would investigate the child's absence and enforce truancy law.

### 3. Action Steps

Describe the action steps relevant to the implementation of the policy.

When a parent has submitted an annual home education notification to the Superintendent, according to Ohio law, the Superintendent (or designee) must review the notification within 14 calendar days and respond to the parent, in writing, either excusing the child or requesting information that was not provided.

The designee who may be reviewing the notification can be a staff member, but only the district superintendent may sign the excusal letter sent to the parent.

Notifications must include all of the elements in Ohio Administrative Code 3301-34.

Review parent's Home Education Notification for compliance. Excusal letter for parent/child issued and signed by superintendent within 14 days. Enroll student into PowerSchool.

If parent's notification is incomplete, notify parent in writing within 14 days requesting information that is not provided.

If the Superintendent finds the parent's notification to instruct a child at home has not been submitted, is incomplete or does not comply with the laws, the attendance officer would investigate the child's absence and enforce truancy law

- #11-Academic Assessment report from previous school year
